GUARDIAN AGREEMENT 2018

Terms of Guardianship

Dominic Bachman of Bachman Bay Kennels LLC, herein after referred to as the Primary Owner, agrees to transfer Guardianship of the following puppy to _____, herein after referred to as the Guardian. The intent of this agreement is to provide the Guardian with a GWP at a significantly reduced purchase price of \$500 to have dog included in the Bachman Bay Kennels breeding program. Ownership of this dog, listed below, remains the property of Dominic Bachman of Bachman Bay Kennels, for the period of ten years. At that time ownership will transfer to the Guardian spay/neuter recommended but not required. The Guardian has no ownership or interest in any puppy/egg/or semen produced by this dog.

Guardian Obligations and Responsibilities:

- Bachman Bay Kennels do not ship puppies via Air Cargo or by bus. You must coordinate “in cabin” transport for yourself and pup, we will provide you with anticipated pickup. Private ground transport is always an option, you are welcome to drive provided you have adequate means to safely transport a young pup, please consult and confirm with us your plans and preparations. On rare occasions, we can entertain making a delivery. Professional ground transport services are subject to approval of the Primary Owner. Please don’t wait until the last minute to make your arrangements.
- Guardian must provide the puppy/dog an INDOOR environment. No puppies from Bachman Bay Kennels may be strictly outdoor pets. Also, no puppy will be chained or tied out as a primary means of outdoor exposure (except for using a tie-out during hunting training in a group with an experienced professional).
- Guardian agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping the puppy/dog parasite free and up to date with vaccinations, proper nutrition, which consists of a good quality kibble given at regular intervals, and fresh water available at all times. The Guardian promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision. Guardian agrees to keep the puppy slim throughout pup’s normal growth period (2 years). Bachman bay Kennels strongly recommends the guardian get pet insurance for this dog.
- Guardian agrees to keep puppy of equal or less than 16-18 weeks of age away from the ground or floor of public places such as pet stores, dog parks, groomers, vet offices until the DHPV series is complete.
- Guardian is to send a copy (electronic PDF is preferred) of ALL veterinary care documentation to Primary Owner within 1-week of care or service provided to include but not limited to: exams, vaccinations, illness and/or injury.
- Guardian agrees to socialize/train puppy throughout its lifetime. An obedience class is highly recommended between 4-6 months of age. Training/socialization responsibilities include: proper housetraining, dog should be reliable within 6-months. Crate, leash and basic obedience (‘come’, ‘sit’, ‘stay’, not jumping on people, dashing out through doors, etc.) training. - Guardian IS responsible for having a minimum of two months of professional field training accomplished at the Primary Owners choosing, to start at approximately 8-months of age. Transportation, and all associated costs are at the Guardians expense. Any costs more than \$1400 dollars would be at the primary owner’s expense.

- Guardian agrees to assist with transportation to hunt tests, training and for use as a hunting dog. The primary owner may need to have the dog for several months prior to hunt tests in order to prepare the dog for the test. The primary owner agrees to pay for all hunt test entry fees and will assist the guardian in running the dog in hunt tests or the primary owner will run the dog without the guardian. The guardian agrees to allow the primary owner to keep the dog for at least one month during the fall and winter to use the dog to hunt wild birds.
- Male: Keep dog away from females in season to prevent accidental breeding and/or creating mixed-pups.
- Guardian agrees to notify breeder of any change of address and/or telephone number during life of puppy.
- Guardian agrees to assist and/or not impede the Primary Owner with health screening. If the dog is under the care of the Guardian and at or over 24 months of age, the Primary Owner may request the Guardian to begin the process of health screening: Hips, Elbow, and Eyes. All health screening requests must be fulfilled within 1-month of being requested. All screening events are reimbursable from the Primary Owner within 1-month of providing receipts (pass or fail). If the dog is with the Primary Owner and at or over 24 months of age, screening will be accomplished at the discretion of the Primary Owner.
- In the event the dog does not pass Bachman Bay Kennels health, personality or hunting screening requirements the Guardian will not be required to pay any more for the dog and be allowed to keep the dog as a pet. Spay/Neuter recommended and done at the Guardian's expense.
- The above puppy is purebred and is registered with the NAVHDA, and AKC and registrable with other sporting organizations. The pedigree is true and correct to be the best of the Primary Owner's knowledge. All other bodies the dog may be registered with, the Primary Owner must be consulted with prior to and once agreed, must be included on all documentation. Altering or omitting any portion of the dog's registered name is not permitted.

Should the dog die of natural causes or accidental causes while in the possession of the Guardian this agreement shall terminate. Should the dog die during the possession of the Primary Owner this agreement shall terminate.

At anytime the Primary Owner finds non-compliance of this agreement, the contract terminates, and possession shall immediately return to Primary Owner. This document may be modified with a written agreement signed by the Primary Owner and Guardian. Reasons for modification may include, but are not limited to, geographical limitations and suitability or temperament of dog for breeding.

UNDER NO CIRCUMSTANCES IS THIS DOG TO GO TO A SHELTER OR RESCUE! If Guardian cannot keep the dog, the dog must be returned to the Primary Owner unless a written agreement is signed by the Primary Owner stating that the Guardian can sell the puppy to a third party.

If the Guardian has the dog spayed or neutered at any time without the written permission of the Primary Owner, the Guardian will owe the Primary Owner up to \$4000*.

If the Guardian allows a female dog to be bred without written consent of the Primary Owner, the Guardian will owe the Primary Owner \$2,500 for every puppy produced in the litter*.

*ALL Legal costs incurred to collect payments will be paid by the Guardian.

For female dogs the Guardian must notify the Primary Owner by BOTH phone and e-mail at the first sign of estrus, for every cycle until after breeding age. Guardian will be required to have progesterone testing accomplished at the request of the Primary Owner. Progesterone testing will be reimbursed by the Primary owner within 1-month of testing documentation being provided. Once 'P-levels' are determined to be satisfactory, the Guardian will make the dog available for transportation within 24 hours. Transportation expenses are the responsibility of the Primary Owner. If travel plans of the Guardian will interfere with an expected estrus associated with breeding plans, the dog will be transferred to the Primary Owner well in advance to eliminate missing the cycle – timings open to negotiation for the best interests of both parties.

For male dogs the guardian may be asked to host a breeding at their residence or take the dog to the vet for semen collection. Any costs incurred for breeding are the responsibility of the primary owner.

Primary Owner Obligations and Responsibilities:

- Primary Owner starts all Guardian puppies with a LIMITED REGISTRATION. Any dog with limited registration is not eligible to be bred, and if it is, none of its offspring can be registered.
 - Your name will appear on the dogs' pedigree as a secondary owner. This is STRICTLY to allow you to participate with the dog in AKC and NAVHDA events for example: Show, Agility, Hunt & Retrieving tests, but not limited to.
- Provide Guardian with a healthy puppy.
- Pay all veterinary costs associated with Hip and Elbow testing, CAER Eye exam, Progesterone testing, and other breeding related expenses (ultra-sound, etc. if the Dam is to remain with the Guardian for birthing). The Guardian is responsible for all non-breeding related expenses to include but not limited to: vaccinations, deworming, parasite control, food, regular and emergency veterinary expenses.
- Pay all costs associated with registration and attendance of hunt tests.
- Provide Guardian with dog care support when requested for the life of the dog.
- Female: Be responsible for arranging and managing all aspects of breeding, birthing and whelping. Communicate with Guardian on breeding plans and timing of estrus cycles for breeding and transportation requirements approximately 60 days prior to the estimated time of

estrus to begin. Male: collections for Artificial Insemination are fully reimbursable. If the Guardian assists with transportation or some other element related to breeding, documented expenses are reimbursable.

- Provide information on detecting and caring for a dog in estrus (heat).

Legal

Guardian understands this is a legally binding contract and is under the jurisdiction of the State of Washington. All disputes will be resolved in the state of Washington in a court of Primary Owner's choice. Guardian has read the agreement in its entirety and understands it fully. Guardian agrees to the terms within this contract.
